## **DATA PROTECTION POLICY**

Tenterden Bowls Club will comply with the General Data Protection Regulation 2018 and Data Protection principles, which state that personal information must be:

- Fairly and lawfully processed
- Processed for limited purposes
- Adequate, relevant and not excessive
- Accurate
- Not kept longer than necessary
- Processed in accordance with individual's rights
- Kept secure

Tenterden Bowls Club recognise that the above principles relate to both paper and electronic systems of record keeping.

Personal information will not be disclosed to any other party, unless with specific permission of the person it relates to or when required by law. Any person may request a copy of their information at any time or request that their details be amended or removed from our records at any time (contact the Club Secretary).

Personal data records for members held by the club, either on a computer database with password protected access or as a manual record, may include:

- Name, address and contact details.
- Emergency contact number in case of accident/emergency.
- Records of original membership application and membership renewal.
- Minutes of Committee meetings and associated correspondence which may include references to individuals.

## **DATA CONSENT**

By signing the application form (on page 1) I consent to my personal details being stored in accordance with the club's Data Protection Policy and agree that the data can be used as follows:

- To enable the club to contact me regarding club related business.
